Students interested in the field of auditing are urgently recommended to attend the course Wirtschaftsprüfung (auditing) in addition.

Students interested in the field of managerial accounting are urgently recommended to attend the courses Interne Unternehmensrechnung (managerial accounting) and IFRS basierte interne Unternehmensrechnung (IFRS based managerial accounting) in addition.
