Are students allowed to extend their stay?

The Universitat Internacional de Catalunya will consider a request to extend a student's stay if the following conditions are fulfilled:

- A formal request must be made before 30 November.
- The request must have an academic justification approved by both home and host universities.
- The UIC will evaluate the progress of the student during the first semester (students who fail more than 20 % of their credits will not be allowed to extend their stay).

Deadlines to submit the on-line application and send required documents by email*:

SEMESTER 1: 15th of June

SEMESTER 2: 15th of November

Learning Agreement

Changes in the Learning Agreement:
(Period of 30 days after classes have started)

The student has to register on our on-line registration platform called RELINT: <http://www.uic.es/relint2/> and pick the subjects provided by the Faculty of Economics and Social Sciences.

Some rules related to subjects' choice:

Master's Degree:

- All subjects are taught in Spanish.
- Incoming students are allowed to take up to 15 ECTS.

Bachelor's Degree:

- Students are allowed to take subjects from either the Law or Humanities departments. The academic coordinator in charge of each department will have to confirm your choice.
- Students should take between 20 and 30 ECTS per semester.
- Students who are staying for the whole academic year will have to choose the subjects for the first and the second semester.
- Check there is no overlapping between subjects.
- The Learning Agreement has to be sent to the academic coordinator for its approval via RELINT.
- There will be a compulsory meeting at the beginning of every semester where the process and the policy of enrolment at the Faculty of Economics and Social Sciences will be explained.

Enrolment must be done before classes start.

Once classes have started, students have 30 days to make changes to the subjects enrolled in.

How to proceed:

1. Contact academic coordinator UIC
2. If academic coordinator UIC approves changes, contact academic coordinator Home University
3. If academic coordinator Home University approves changes, contact our international office at exchange.bcn@uic.es so we can introduce your changes in RELINT.

After 30 days, no further changes will be accepted either to the Learning Agreement or the enrolment form.

Examinations

Overlapping exams

When exams overlap, students must inform the academic coordinator at least 2 weeks in advance to find a solution.

Justifications for being absent

- Only in very specific cases can students justify their absence.
- Absence from an exam is equivalent to NS (no-show).
- Copying during any examination earns a "zero" mark.

For more details, students should consult the internal regulations of the UIC.

Other regulations

Class attendance

Attending class is compulsory. In case of not being able to attend, it is necessary to present a justification. Students with an attendance record of below 50 % can be expelled from the course.

Are visiting students allowed?

Yes, and they do not have to provide any extra documents.

Master's, PhD courses

Students enrolled in the second year of a master's programme in their home university can enrol for the Master's Degree in Business Administration and Production Systems. However, since the master's course is taught in Spanish, students must hold a B2 Certificate in Spanish.

We accept Spanish certificates issued by the home university.

Required level of English

TOEFL (550 written test, 213 computer-based, 65 internet-based), First Certificate, IELTS (6.5).

We accept English certificates issued by the home university.
