

#### GLO Berlin 2024

From 18-20 April 2024, the Global Labor Organization (GLO) conference took place as a hybrid conference in Berlin, organised jointly with EBES 47 and the FOM University of Applied Sciences, Berlin. Klaus F. Zimmermann (Honorary Professor of Economics), who is also GLO President, was the main organiser.

#### Anniversary conference of the Berlin Network for Labour Market Research

Annica Gehlen, Peter Haan, Andreas Leibing and Johannes Seebauer, together with Felix Fuchs (HU Berlin) and Katharina Wrohlich (DIW and University of Potsdam), organised the conference to mark the 20th anniversary of the Berlin Network for Labour Market Research (BeNA). BeNA was established in 2004 to provide a forum for young labour market researchers to present and discuss their work. From the very beginning, it was coordinated and organised by young researchers from institutions in and around Berlin. The conference took place on 14 and 15 March 2024, and the keynote lecture was given by Professor Abi Adams-Prassl (University of Oxford).

## Third-party funded projects

Andreas Asseyer, Die Gestaltung verifizierbarer Informationen unter Wettbewerb (engl. The design of verifiable information under competition), DFG Middle East Cooperation, Project duration: 10/2024 - 09/2027, with Ran Weksler (University of Haifa)

In this research project, we want to analyse how competition influences the design of certificates and the dissemination of market information. The production of credible information in economic contexts

involves three different groups of actors: Certifiers generate verifiable information for senders who provide this information to receivers. By utilising current methods of theoretical information economics, our research project aims to generate an improved conceptual understanding of the mechanisms by which competition within these three groups influences the production and distribution of credible market information.

## Project Wealthy, Wealthier, Wealthiest - The Role of Inheritances and Parental Background for the Structure of the Wealth Distribution and Top Wealth

The aim of this project is to provide new insights into the under-researched upper end of the wealth distribution: How one gets there and how different mechanisms shape the accumulation of high wealth. Germany will serve as the research laboratory for this project, and new data, the German Socio-Economic Panel together with its Sample of High Net Worth Individuals (SOEP-P), will serve as the empirical basis. The project, which will be led by Prof Dr Martin Biewen and Carsten Schröder (S-Professorship for Public Finance and Social Policy) and will start in summer 2024, is funded by the Thyssen Foundation.

#### Hans Böckler Foundation funds new doctoral programme

The Hans Böckler Foundation is funding the doctoral programme "EQUALFIN: Financial system and inequality in the context of multiple crises". The spokespersons of the project are Barbara Fritz (Chair of Latin American Economics) and Heike Joebges (HTW Berlin). In addition to Barbara Fritz, Natalia Danzer, Britta Gehrke, Theocharis Grigoriadis, Jan Marcus, Peter Mohr and Manuel Santos Silva from the department are also involved in this doctoral programme. Up to 12 doctoral students are funded via scholarships as part of the doctoral programme.

The doctoral programme aims to investigate the interaction between the financial system and socioeconomic inequality at national and global level as well as new trade-offs arising from the financing of the ecological transformation at macro- and micro-economic level. The cooperative doctoral programme is designed as an innovative pilot project between the FU Berlin and the HTW Berlin. There are four thematic research areas:

- Financial sector and inequality from a global perspective
- Financial sector and inequality in the context of ecological change
- Unequal access to funding at the individual level
- Unequal finances and their consequences for social security, property markets and economic development

## From the deanery

## From the library

#### 1st Alumni Talk on 23 January 2024



The department's first alumni talk took place on 23 January 2024 in the library's reading room and was very well received. This new format gives former graduates of the department the opportunity to present topics from their professional practice to future graduates. Andreas Häntsch (Senior Dir4ector Seller Engagement eBay GmbH) kicked off the event with his presentation "Online marketplaces: The nail in the coffin of stationary retail? or the saviour in times of need?" The new series of events is organised by Wiwiss Alumni.

#### Saturday opening 10.2. and 17.2.

In the winter semester 2024, the library was open on two Saturdays (10 February and 17 February) during the exam period thanks to the support of the library assistants. The Saturday opening was very well rece+ived by the students. The library is endeavouring to maintain and, if possible, extend the Saturday opening hours during the exam period.

#### New feature: secondary publication service

Since the beginning of 2024, the library has been supporting researchers in exercising their secondary exploitation rights from the start of publication. To this end, researchers are asked to send the post-print publications (the version accepted by the publisher) to the library immediately upon acceptance by the publisher. The library will then manage the document, check the right to secondary publication and finally - as soon as the secondary publication is permitted - upload the publication to Refubium, the repository of the FU, open access.

#### Continued licensing of important research databases until 2026

The following important research databases can continue to be offered up to and including 2026: DAFNE, EIKON, Wharton Research Data Service (Audit Analytics, BoardEx, Compustat, Orbis Europe). The Wharton Research Data Services are financed from central funds of Freie Universität Berlin. Training courses on the use of these databases are regularly offered by the library.

#### Itemised list of new loanable stocks according to RVK from 2024



From 2024, the new loanable book collection will be organised according to the <u>Regensburg Union Classification</u> (RVK) in the foyer of the library for better orientation on the shelf. The specialised arrangement offers the opportunity to discover and view related titles right at the shelf. The new location is called "Foyer-Freehand". This now also leads to the standardisation of the book arrangement in the library, as the RVK system has been used for years for the arrangement of the reference holdings in the reading room and the loanable holdings of the textbook collection.

#### New and good: Lean Library

#### What is Lean Library?

<u>Lean Library</u> is a free browser plug-in that accompanies you in your Internet research and gives you the best possible access to electronic resources. Wherever you search - on Google & Google Scholar, Wikipedia, JSTOR, Amazon etc. - Lean Library shows you additional hits from Primo and databases.

#### How does Lean Library work?

Once installed, it directs you to digital content from the libraries of Freie Universität or to freely available open access texts. If you search for articles on Google, for example, Lean Library offers a link to the full text version if it is available for Freie Universität Berlin. Information on the availability of physical copies is also displayed in this case. If the text you are looking for is not available through the university library, Lean Library provides a reference to the open access version, if it exists, thus facilitating access to academic digital content.

#### Prize for gender-related theses at the Department of Economics

## Anti-discrimination statutes & statutes to ensure and promote equal opportunities for all genders at Freie Universität Berlin

The canon of values and thus the fundamental self-image of Freie Universität Berlin includes respectful, equal and discrimination-sensitive cooperation between all university members. In October 2023, the Academic Senate specified these basic pillars of cooperation in the newly issued anti-discrimination statutes and the statutes for ensuring and promoting equal opportunities for all genders at Freie Universität Berlin (equal opportunities statutes), which were confirmed by the Presidential Board in February 2024. The statutes can be found in the official gazette of Freie Universität (FU-Mitteilungen 3/2024).

#### Girls'Day 2024 at the Faculty of Business and Economics

Once again this year, Freie Universität is participating in the nationwide Girls' Day. On 25 April, researchers, primarily from the mathematics and natural sciences departments, will offer more than 35 workshops for schoolgirls in grades 5 to 10. Registrations for the workshop programme at various FU locations are possible from now until 18 April 2024 via the nationwide Girls' Day radar.

At the Department of Economics, Prof Dr Jana Möller-Herm, Prof Dr Aline Grahn and Catalina Wache will be working on the topic of "Green consumption - the role of sustainability in our everyday lives" with the schoolgirls. Please feel free to invite schoolgirls from your family or circle of friends to register for a Girls' Day programme at Freie Universität.

On Girls' Day, girls learn about professions in which there are fewer than 40 per cent female trainees or students. As the goal of approximate gender parity has already been achieved in most business-related professions, the Wiwiss department will not be able to offer a workshop from WE1 for Girls'Day next year. The decentralised women's representatives would therefore be very pleased if a workshop related to economics could be jointly designed for the Girls'Day next year.
